

GÉANT OCRE2024 Framework Buyer's Guide

This Buyer's Guide is an instruction on how to purchase cloud services via the GÉANT OCRE 2024 IaaS+ Framework Agreement, compliant with EU public procurement rules.

The OCRE 2024 Framework Agreement is a procurement vehicle for simplified purchasing of Cloud Services for Institutions in Europe in this case, NRENs, their member Institutions, and others, i.e. Legal entities listed in the List of Participating Entities.

The information provided within this document has been verified with your National Research and Education Network (NREN), FCT|FCCN, as meeting the procurement and legal requirements of your country. Your institution may have additional local procurement and/or legal requirements which you still need to verify with the appropriate procurement contacts within your organisation (Section 4).

1. Scope of the Framework

GÉANT carried out a European-wide Framework Procurement for:

- Infrastructure as a Service (IaaS),
- Platform as a Service (PaaS) and
- Software as a Service (SaaS)

FCT|FCCN has played a key role in validating the Framework process and deciding on the appropriate procurement mechanism to be used for your country. FCT|FCCN will claim 2% cost recovery fee.

2. Awarding procedure

An Institution who would like to sign a Call-Off Contract must go through an awarding procedure as described below depending on the specific circumstances of the procurement and be compliant with public procurement law:

- 1) Direct Award via cascade method without re-opening competition
- 2) Mini-Competition
- 3) Desktop mini-competition based on Awarding Criteria from the original tender and Service Provider Bids

Your Cloud Services Delivery Manager (CSDM) can also support you in the awarding procedure.

3. Duration of the Framework

A Call-Off contract can be concluded with any of the Service Providers from the list of Service Providers available for the Portugal any time between 03/02/2025 and 02/02/2030. Each Call-Off Contract may be for a duration of up to five years.

4. Guide and OCRE2024 info-packs

Upon request the following OCRE2024 procurement documents will be available to you on a confidential basis provided in the OCRE2024 info-packs:

- The Framework Agreement including all tender documents incorporated by reference. The Framework Agreement is the overall contract signed between GÉANT acting as central purchasing body and the Cloud Service Providers beneficial to all Participating Entities. This is the master document available in Word and PDF (for signed version) and includes a number of separate schedules that are also listed below.
- Call-Off Contract template: The agreement between your institution and the Service Provider, which includes the following Appendices:
 - Contract Details: A summary of the details of the contract, to be completed by the Institution and Supplier.
 - Order: The Order has contractual preference. The Institution needs to insert their order as customer. *Note: where an Order from a Customer contains a document or form provided by the Counterparty, no Service terms or conditions referenced in this document are applicable.*
 - GÉANT Terms and Conditions for IT Contracts as modified for IaaS+
 - The Deliverable including fees: The Services Provider specific offer based on the Institutions' demand – Order.
 - Service Providers Services Terms and/or OIP enrolment if applicable.
- GÉANT Terms and Conditions for IT Contracts as modified for IaaS+
- Supplier's Offer
- List of Framework Providers
